### **CRUISE INCENTIVES**

2. Group Leader must submit rooming list (which we will confirm with The Cruise Authority). Note: Please have registrants select **GROUP LEADER** on the line that asks, “How did you Hear About the Cruise?” and also list **YOUR NAME** on the line provided on the application or, if they are signing up on-line, list your name in the **SPECIAL REQUESTS & NOTES** section as their group leader.
3. Submissions should be received by April 1, 2009. (Please contact Vikki Wells if you require an extension.)
4. Rooming list will be reviewed and verified before the FREE Cabin is awarded. (Note: Cabin Category is determined based on overall sign-ups and cabins requested).
5. Group leaders who attend the cruise (at their own expense) and book another cabin (excluding their own) with 2 or more guests **AND** Group leaders who are not able to attend the cruise but book 2 or more cabins with 2 or more guests may request the **CASH Incentive**.

**CASH Incentive (Ready to Win Cruise ONLY. )**

Cabin Category	Group Leader CASH Incentive
GS	\$90.00 pp
JS	\$85.00 pp
D1	\$60.00 pp
G	\$35.00 pp
N	\$25.00 pp

**(Note: The CASH Incentives above are for the READY TO WIN CRUISE ONLY. Once land conferences begin, cash incentives will NOT be an option as these conferences are FREE to the public.)**

1. In order for Group Leaders to receive their CASH Incentive payout, they **MUST** request the cash amount equivalent to the numbers of persons who booked the cruise under their name within **45 days AFTER the last day of the cruise** and include the names of said persons for verification. For example, if 4 guests attended the cruise under your name (excluding yourself) and two booked cabin category G and two booked cabin category JS, the Group Leader will be entitled to \$240.00. **(IMPORTANT: If Group Leader DOES NOT CLAIM her CASH Incentive within 45 days After the last day of the cruise, the ministry will assume that Group Leader intends to bless the ministry and funds will be used to continue the ministry of A Woman of God Ministries.)** A Woman of God Ministries will have 45 days after receipt of Group Leader's CASH Incentive request to process the request and mail payment.
